Iowa Campaign Contributions by Greyhound Breeders & Their Lobbyists (January 2003 through May 2010)

July 2010



Overview

In 1995, the Iowa legislature approved slot machine gambling at Iowa racetracks. As part of this law, the state required that dog races be conducted as a condition of operating the gambling devices. Additionally, lawmakers required that greyhound breeders be subsidized with a portion of slot machine profits.

As a result, greyhound racing in Iowa today is heavily subsidized. In 2009 alone, greyhound breeders received nearly \$14 million in prizes¹ after their dogs competed at Iowa racetracks, virtually all of this money from slot machine subsidies.²

Meanwhile, interest in greyhound racing continues to decline. According to the Iowa Racing and Gaming Commission, the total amount gambled on live dog racing at Bluffs Run has declined by 96% since 1987.³ At Dubuque, wagering on live dog racing has declined by 95% since 1988.⁴

In 2010, a proposal was debated in the Iowa legislature that would have allowed racetrack casinos to continue operating without having to conduct greyhound races. Additionally, the proposal would have returned millions in slot machine subsidies to the state, to be used for other state programs. Despite having significant support, this proposal was not approved. It is likely, however, that a similar measure will be debated in the 2011 legislative session.

To better understand this issue, GREY2K USA has completed a report on campaign contributions by greyhound breeders. In particular, we wanted to determine whether a correlation exists between those greyhound breeders who are receiving slot machine subsidies and those making contributions to political candidates.

After examining the data, it is clear that such a correlation does exist. In essence, it appears that some of the subsidy dollars being given to greyhound breeders are being recycled back to Iowa lawmakers in the form of campaign contributions.

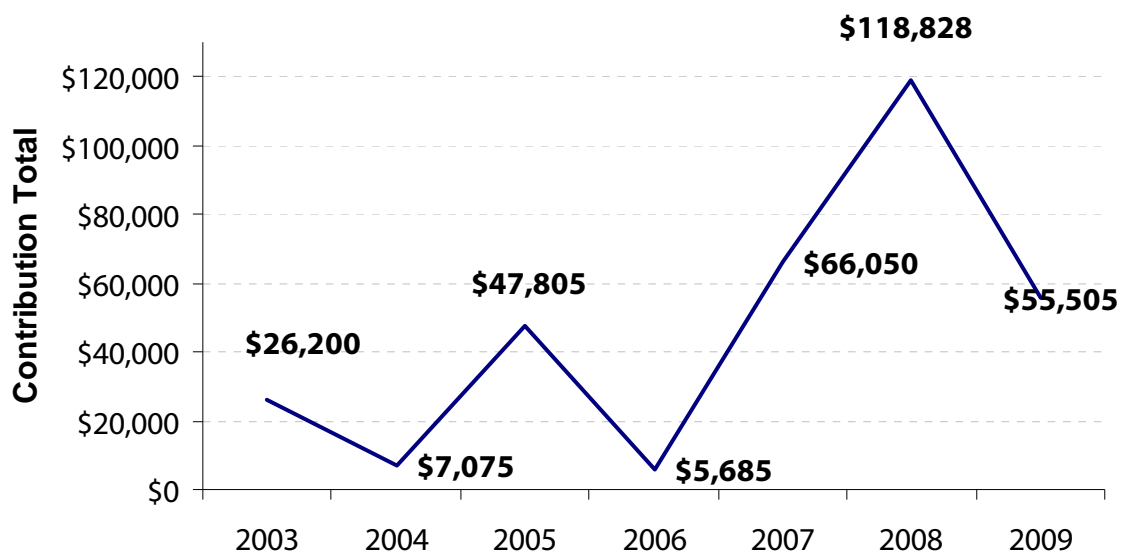

Specific Findings

- Between January 1, 2003 and May 14, 2010, greyhound breeders and their lobbyists have made **459 campaign contributions** for a total of **\$333,998.00**.⁵
- The vast majority (94%) of campaign contributions made by greyhound breeders and their lobbyists were given to **Democratic candidates and committees**.⁶
- There is significant overlap between those greyhound breeders who are receiving the largest slot machine subsidy payments and those giving campaign contributions. For example, the top 10 givers of campaign contributions each received an average of **\$510,014.56 in slot machine subsidies** in 2009.⁷
- The number of campaign contributions being made by greyhound breeders to Iowa lawmakers and candidates **has increased** over the past seven years.⁸

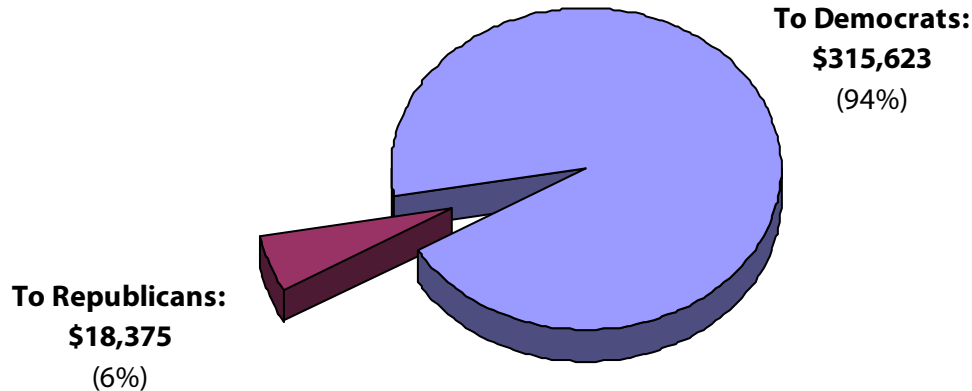
